**Clinic based Occupational Health Follow-Up £90**. Up to 1-hour long face to face appointment to review and provide appropriate treatment and subsequent specialist documentation

**Workplace based Occupational Health Initial Assessment £170**. Includes a 1-hour clinic assessment and 1-hours documentation time to produce a full report with an executive summary and recommendations.

## Letters & Reports

Additional reports and/or letters are charged in respect of the total time taken to prepare them. Charges are based on the standard clinic costs of £75 per hour.

Telephone conversations over 15 minutes will be charged and are again based on standard clinic costs of £75 per hour.

Any additional basic administration work will be billed at £25.00 per hour.

#### Payment Terms

Payment for Occupational Health Assessments and follow-ups must be **made via the emailed invoice at the time of booking, prior to the appointment.** 

Payments can be made using the invoice payment button, powered by Square, or details for BACS payment, can also be found on the invoice.

# Cancellation Policy

Turra Physio requires 24 hours-notice to re-arrange appointments.

### If you/your client need to cancel / re-arrange any appointments, please give us a minimum 24hrs notice.

You can contact us to re-arrange an appointment by telephone (07354 471470) or by email (hello@turraphysio.co.uk). Out of normal working hours there is an answerphone for you to leave a message.

We are aware that due to the nature of our service some individuals will have to cancel with short notice, however we must treat all clients the same and with less than 24-hours-notice we are unlikely to fill that appointment slot. Therefore, **failure to provide 24 hours-notice of a cancellation** for any reason **will incur a late cancellation charge for full the cost of the appointment** – cost of the Occupational Health appointment and, if a work base visit, the travel time, as in the fees above.

### Clinic Appointments

If as a client, you are late for your scheduled appointment your time allocation will be impacted. If you are over 15 minutes late for your appointment it may be necessary to book a further appointment to complete your initial assessment or planned treatment session. You will be charged for the session booked (see Cancellation Policy). This is to ensure that you receive a comprehensive and effective intervention and service.

# <u>GDPR</u>

All data held by us is processed in accordance with GDPR.

## <u>Consent</u>

Clients are required to consent to assessment and treatment. They are expected to respect the clinician during the treatment sessions. Aggressive and/or abusive behaviour will not be tolerated. Additional permission will be required for audio /video recording and for the circulation of reports to other relevant professionals.

### <u>Withdrawal</u>

The client is free to withdraw from therapy at any time without stating a reason provided that 24hrs notice is given for any booked appointments.
